- 1. Opened Public Hearing for rezoning request for city lots at 7:01pm
  - a. The city has proposed the rezoning of the Main Street lots from R-1 Low Density Residential to R-2 High Density Residential to allow for multi-unit residential dwellings to be constructed.
    - i. R-2 zoning allows up to four units. Parking requirements are two spots for each unit.
  - b. City lot proposal Scott Rech, Stix & Brix, Inc.
    - Randy Redman and Scott Rech (Stix & Brix Inc) presented a plan for the purchase of the Main Street lots for market value with the intention to construct two multi-unit buildings.
    - ii. Presented a purchase agreement to purchase the Main Street lots for the tax roll value of \$23,300. This will be presented to the city council on Monday, August 18, 2025.
